3. Word Limit: 2000-3000 words (excluding footnotes).
4. Formatting specifications:
 - a. Font and size for the essay: Times New Roman | 12
 - b. Font and size for footnotes: Times New Roman | 10
 - c. Line spacing: 1.5
5. Uniform style of citation (follow Bluebook 20th Edition)
6. The file name must consist only of the author's name; in case of co-authorship both the authors name.
7. Essay must be in .docx or .doc.
8. The competition shall be in English only.
9. Write-ups shall have no plagiarism and should be an original work of the participants.
